

Tredegar Board Declares Dividend

RICHMOND, Va.--(BUSINESS WIRE)--May 22, 2013-- The board of directors of Tredegar Corporation (NYSE:TG) declared a quarterly dividend of seven cents (\$0.07) per share on the company's common stock. The dividend is payable on July 1, 2013 to shareholders of record at the close of business on June 14, 2013.

Tredegar Corporation is primarily a manufacturer of plastic films and aluminum extrusions. A global company headquartered in Richmond, Virginia, Tredegar had 2012 sales of \$882 million.
