RICHMOND, Va.--(BUSINESS WIRE)--Feb. 27, 2014-- The board of directors of Tredegar Corporation (NYSE:TG) declared a quarterly dividend of seven cents (\$0.07) per share on the company's common stock. The dividend is payable on April 1, 2014 to shareholders of record at the close of business on March 14, 2014.
