

Tredegar Board Declares Dividend

RICHMOND, Va.--(BUSINESS WIRE)--Aug. 3, 2016-- The board of directors of Tredegar Corporation (NYSE:TG) declared a quarterly dividend of eleven cents (\$0.11) per share on the company's common stock. The dividend is payable on October 1, 2016 to shareholders of record at the close of business on September 16, 2016.
