

Tredegar Board Declares Dividend

RICHMOND, Va.--(BUSINESS WIRE)--May 17, 2017-- The board of directors of Tredegar Corporation (NYSE:TG) declared a quarterly dividend of eleven cents (\$0.11) per share on the company's common stock.
